1. **Issue of Application Forms:** From 13th to 17th March, 2023
2. **Last Date for Submission of Filled-up Application Forms:** 20th March, 2023
 (On all working days, only between 2:00 p.m. and 3.30 p.m.)
3. **Streams and Subjects Offered:**

- ❖ For each of the Optional Subject maximum 33 students across the streams will be admitted.
- ❖ Candidate opting Physical Education as Elective Subject must produce fitness certificate from registered medical practitioner.

4. **Eligibility Criteria for Admission:**

i) **For Commerce Stream :**

- Without Mathematics: 65% and above in aggregate
- With Mathematics: 65% and above in aggregate with minimum 75% in Mathematics.

- ii) **For Humanities Stream:** 65% and above in aggregate
- iii) **For Science Stream with Biology :**
 - Without Mathematics.: 75% and above in aggregate with 75% in Science
 - With Mathematics.: 80% and above in aggregate with 75% in Science and Mathematics (Standard).
- iv) **For Science Stream with Mathematics:**

80% and above in aggregate with 75% in Science and Mathematics (Standard).

5. Admission Procedure:

- i) The Application Form will be issued from the School Accounts Office. The Registration charges will be Rs. 400/-. The Application Form is not transferrable.
- i) Please note that the Registration of Application Form, appearing for test and interview does not entitle or guarantee admission to a candidate. Admission shall be confirmed only after declaration of Board Exam result.
- ii) All students, who are aspiring to seek admission in Class-XI at Anandalaya will have to register their candidature and it is mandatory to appear for aptitude test (max. marks 50) and interview. The date will be tentatively 24th March 2023.
- iii) Admission would be granted subject to fulfillment of eligibility criteria, performance in the aptitude test and interview. List of candidates provisionally selected will be published on the School Notice Board.
- iv) Preference will be given to the candidates from Preferred institutions//Olympiads/those having outstanding performance in sports and other fields.
- v) The Candidature is liable to be cancelled if any information is found to be incorrect at any stage.
- vi) As there are limited seats in all the Streams, the School Management reserves the right to offer admission to suitable candidates only.
- vii) If a student is unable to perform in his/her chosen stream or subject and seeks to change, he/she will be allowed to do so by after declaration of Board Examination result subject to vacancy, if any in the stream or subject in consultation with his/her parents. The student will be expected to cover the syllabus completed himself/herself. Parents and Students are therefore advised to write the order of preference of the subjects opted in the Admission Form with due consideration and care.
- viii) Provisional classes will begin from April 2023.

- 6. **Fee Schedule:** The details of fees to be paid through Demand Draft at the time of admission will be displayed on the School Notice Board. Fees once paid will not be refundable in any case. The School reserves the right to revise Fees and Other Charges.

7. Documents and other essential items to be submitted:

- i) Birth Certificate of the Child
- ii) Attested photocopy of the Result of Class IX and X (PT-I, II, III & Pre-Board). Please bring original for verification purpose.
- iii) Board Admit Card.
- iv) Two latest passport-size colour photographs of the student in previous school's uniform.
- v) Attested photocopy of AADHAR Card (Mother, Father, Child)
- vi) Attested photocopy of Residential proof.
- vii) Caste Certificate if belongs to SC/ST/OBC/EWS/BPL
- viii) Fitness certificate if opting PE
- ix) Attested photocopy of Olympiads/Aptitude Test result/reports.

Only after confirmation of admission based on final eligibility:

- x) Transfer Certificate and Character Certificate in original issued by the previous school.
- xi) Students migrating from other Board Schools or Board other than CBSE, shall get the Transfer Certificate counter signed by District Education Officer.

8. Parents and Students shall not buy text books and uniform unless the admission is confirmed by the school after declaration of result by the Board, subject to final eligibility as mentioned in point no.4

9. The School Management reserves the right to add, alter, amend or cancel any of the rules, procedures prevailing at any time which will be binding on the students and parents/guardians. All decisions of the Admission Committee will be final and binding.
